**Multi-Child Discount:**

RWS offers a reduced tuition rate for multiple children in the same family. There is no reduction for the first child (highest tuition rate.) Second child will receive a 20% discount, third child will receive a 40% discount, fourth child will receive a 60% discount.

**Payment Schedule:**

Enrollment fee is due with contract.

Activity fees due are on June 1, 2008.

Annual Tuition payment is due by July 15, 2008.

Biannual Tuition payments are due by July 15, 2008 and January 15, 2009.

Monthly Tuition payments are due by the fifteenth of each month from July 2008 through June 2009.

**Late Payment Fee:**

All tuition payments are due on the 15th of the month. A late charge of \$20 will be assessed to your account if any payment is not received within 10 days from the payment due date.

**Suspension for Non-payment**

The School reserves the right to suspend any student(s) whose tuition payment falls in arrears by more than 30 days beyond the due date.

**Dismissal for Non-payment:**

The School reserves the right to dismiss any student whose non-payment of tuition has caused suspension on

multiple occasions.
