## **Remission Policy**

The history of BOT's work on the the remission policy was shared and there was discussion regarding when/how the policy was implemented

#### Auction

There are big changes for the big fundraising event for this year to to make more money & bring in the larger community

Earnings are estimated as being in the \$20 - 25,000

Tickets will be in the \$30 - 35 range but thinking of a VIP option that might cost more

An account of the Circus Zirkus RVA will be distributed to the community.

Questions were raised regarding part of the proceeds going to a private cause ⇒ ACTION ITEM: a proposal will be sent to the BOT via email, and the BOT will decide whether proceeds can go to this cause

# **Founders Scholarship**

It was proposed that the Scholarship Committee create a charter which outlines what it is tasked to do and how it plans to proceed.

The BOT supported this proposal

A document that outlines the history of the Founders Scholarship in 2010-11 has been compiled. It addresses the questions of whether the Board was involved in creating, reviewing or approving the criteria for the scholarship.

⇒ ACTION ITEM: This document should be shared with the BOT

AH reported on open house at St. Andrews school; was glad to be able to speak about the scholarships to prospective parents; spoke about Orchard House's comments about their financial aid program which has not been able to support a diversity of economic classes; Sabot School has no tuition adjustment at all. AH felt very good about our schools ability to offer these scholarhsips

## **Nominating**

A letter from a nominee was read. She isn't able to join the BOT at this time because of personal reasons but thanked the Board for the invitation.

#### **Finance**

Reports that there will be \$10,000 for administrative expenses this year.

A Financial Audit would cost about \$5,000

Cost for Exit Interviews not known

It was reported that LRP visited the Fulton Hill school and will review the issues that the visit raised.
